On May 22, 2025, Maravai LifeSciences Holdings, Inc. (the "Company") held its 2025 Annual Meeting of Shareholders (the "Annual Meeting"). On March 24, 2025, the record date for the Annual Meeting, the Company had an aggregate of 254,642,249 shares of common stock issued and outstanding, consisting of 143,958,169 shares of Class A common stock and 110,684,080 shares of Class B common stock (together, the "Common Stock"). The holders of a total of 231,686,324 shares of Common Stock were present at the Annual Meeting, either in person or by proxy, which constituted a quorum for the purpose of conducting business at the Annual Meeting.
